Minutes of the 2nd Annual General Meeting of the 'IAS Officers Association, West Bengal' held on 22nd June, 2018 at the Bidyut Unnayan Bhavan, Salt Lake

Preliminary – In pursuance of the notice given on 1st June, 2018, under clauses 9 and 38 of the Rules & Regulations of the IAS Officers' Association, West Bengal to all members; the 2nd Annual General Meeting of the Association was convened on 22nd June, 2018 at the 3rd floor Conference Hall of the Bidyut Unnayan Bhavan, 3/C, LA Block, Sector – III, Salt Lake, Kolkata - 700098.

Members Present: 39 members present (List attached).

The meeting was chaired by Sanjeev Chopra, President of the 'IAS Officers Association, West Bengal' and the meeting ratified the decisions taken from November 2016 till date as well as the financial statements presented by the Under Secretary and Treasurer.

The key decisions taken are as follows:

Office Bearers as Executive Committee

The President, Sanjeev Chopra and the Secretary, Santanu Basu offered their resignation from their respective posts before the General Body. Upon persuasion by the General Body, they agreed to continue as the President and the Secretary of the 'IAS Officers Association, West Bengal' for 2018-19. It was also decided that the existing EC members except Shri Durgadas Goswami and Dr. Aurobindo Ghosh both of whom retired in April and September, 2017 respectively be requested to continue holding their respective posts.

The names of the following were also proposed and accepted for inclusion in the Executive Committee during the AGM:

Association Website and Annual Subscription

Under Secretary and the Treasurer of the Association displayed the layout & Site Map of the newly constructed website for the IAS Association to all the members present. It was decided that the annual membership fee for the year 2018-19 shall be Rs. 4,000 /- (Rupees four thousand) only per head and all members shall be requested and persuaded to contribute the same. The 'easy to use' payment gateway mechanism was also explained to all. It was further decided that the annual maintenance contract (AMC) for the website shall be given to Webguru Infosystems at a considered amount of Rs.20,000/- p.a. (including GST).

Discussion on Lateral Entry

The issue of lateral entry for 10 (ten) Jt. Secretary posts to GoI was discussed and debated at length and it was decided that the relevant PIL documents shall be studied and the matter will be suitably taken up with the P&AR Department, GoWB. It was decided that the point of rebuttal shall be primarily with respect to the manner of selection for such lateral entry procedure.

Special Posting for Junior Officers and Batch Parity

Considering the growing number of junior officers getting special postings in various departments, it was agreed that these officers who are given special postings outside the field, before they get the Secretary-scale, may be provided with an additional designation of Special Director. This will help these officers to get pay, perks and benefits as applicable to an All India Service officer.

It was also agreed that batch parity should be maintained for the officers. Cases where an officer from the batch is SDO while another is ADM or one officer is DM while another is ADM should be avoided as far as possible.

Both matters shall be accordingly taken up with the P&AR Department.

Professional Training

It was agreed by all that professional training is an integral part of growth in service. It was decided that government will be requested to support the training opportunities for all officers particularly in respect of 'mid-career training programme'. The matter shall be accordingly taken up with the P&AR Department, GoWB.



Library at Nabanna and Knowledge Series

The members appreciated the initiative taken by the Principal Secretary, Mass Education Extension & Library Services Department and the Under Secretary to establish a library at Nabanna. The members also felt that the Association should take pro-active steps to organize a "Knowledge Series" for the interaction of members with the distinguished thought leaders.
